2015 Conference Announcement

The Executive Council of the North Carolina Association for Behavior Analysis (NCABA) is pleased to announce our 26th Annual Conference. The conference will be held in Asheville, North Carolina at the Crowne Plaza Tennis and Golf Resort February 11th - 13th, 2015. Located in the rolling hills of western North Carolina, the 125 acre resort offers spacious pet-friendly guest rooms in the hotel and villas on the property. 2014 Conference Summary

The NCABA Executive Committee would like to extend a big thank you for supporting and attending the NCABA 25th Annual Conference that was held in Winston-Salem, NC at the Twin City Quarter on February 19-21, 2014. The conference included three pre-conference workshops, two post-conference workshops, eight invited addresses, one invited panel discussion reflecting on the past 25 years of Applied Behavior Analysis, a student symposium and eight concurrent sessions devoted to the topic of behavior analysis, as well as our annual poster session and social.

The topics presented at the pre- and post-conference workshops varied, including establishing a modified PBIS approach in a rural intermediate school (Jeannie Golden, Ph.D., BCBA-D, Professor, & Rhys Potts, Kay Exum, Denise Griswold, Jenna Hilgoe, Cary Trump, & Carolina Hines, Graduate Students, East Carolina University), Conducting Functional Behavior Assessments with Typically Developing Students: Efficient and Effective Assessment (Cynthia Anderson, Ph.D., BCBA-D, Professor, Appalachian State University), A Behavior Analyst's Approach to Teaching Social Communication Skills (Tamara S. Kasper, M.S., CCC-SLP, BCBA, Director, The Center for Autism Treatment), Everything You Wanted to Know About Verbal Behavior But Were Afraid to Ask (A. Charles Catania, Ph.D., Emeritus Professor, University of Maryland, Baltimore County), and Function-Based Support: Developing Effective Interventions Based on Results of a Functional Behavior Assessment (Cynthia Anderson, Ph.D., BCBA-D, Professor, Appalachian State University). A total of 89 people participated in the pre-conference workshops and 47 participated in the post-conference workshops. Each workshop provided 3 CEUs for psychologists and Board Certified Behavior Analysts.

A total of 222 people attended the 2014 conference. We were extremely fortunate to have a number of individuals preeminent in the field in attendance and several provided invited addresses that were well attended. Special appreciation is given to our invited speakers including A. Charles Catania from the University of Maryland, Jeannie Golden from East Carolina University, Cynthia Anderson from Appalachian State University, Tiffany Hodges from OptumHealth Insurance Company, Julie Grimes from Animalworks, LLC & Faculty, Davidson County Community College, Dennis H. Reid of The Carolina Behavioral Analysis and Support Center, Marsha B. Parsons of the J. Iverson Riddle Developmental Center, Tamara S. Kasper from the Center for

Autism Treatment, and Carol Pilgrim from the University of North Carolina at Wilmington.

We were fortunate to have a wonderful array of topics presented during eight concurrent sessions. Presenters included Maureen Schepis, (George Mason University), Selene Johnson & Lizzy Donovan (ABC of NC Child Development Center), Rachael Bowman & Holly Moses (Duke University), Tiffany Hodges (OptumHealth), Leah Wood, Caryn Allison, Jenny Root & Julie Thompson (University of North Carolina at Charlotte), Ya-yu Lo, Adrienne Anderson, & Kimberly Bunch-Crump (University of North Carolina at Charlotte), and Jeannie Golden, Emmi Scott, Denise Griswold, Carolina Hines, (East Carolina University), with Dawn Lanaville, Christelle Garza, & Audrey Masilla (Fielding Graduate School).

At the opening of the conference, Kristie Thompson acknowledged the many ongoing contributions of the NCABA Board Members with respect to making NCABA a vital organization and in putting the 2014 conference together. Some very deserving individuals received awards and a big round of applause during the opening session. Doug Irvin (Murdoch Developmental Center) received the Fred Keller Excellence in Behavior Analysis Award, Kristie Toward (Carolina Center for ABA) received the Technical Utilization Award, Kay Exum (East Carolina University) received the Student Scholarship Award, and Carol Pilgrim (University of North Carolina at Wilmington) received the "Do Things" Award. Congratulations to all award recipients!

The NCABA Student Representative, Amy Kemp-Inman from the University of North Carolina at Charlotte, did a wonderful job of organizing and chairing our Student Symposium. Student presenters included Sara Beth Hitt (University of North Carolina at Charlotte), Caitlin A. Kirkwood (University of North Carolina at Wilmington), and Leah Wood (University of North Carolina at Charlotte). Following the symposium, a student gathering was held to provide time for students to network with other students and meet and talk with Student Representative candidates prior to voting.

The poster session included posters from graduate student researchers as well as practicing professionals. This year, we awarded prizes to outstanding posters in three categories: undergraduate, graduate and professional. The winning poster presenters are listed in the NCABA History along with the other Award recipients for 2014. During our annual NCABA Business Meeting, newly

2014 Workshop Series a Success

The North Carolina Association for Behavior Analysis continues to offer opportunities for its members and other interested parties to expand their knowledge and to earn continuing education credits to maintain licensures and certifications. This summer we sponsored three workshops.

In December 2012, the BACB instituted new requirements for BCBA's and instructors who supervise the applied experience of those pursuing certification, as well as BCBA's who supervise the ongoing practice of BCBA's. The most significant of the new requirements is the completion of a post-certification, competency-based training program on supervision by December 31, 2014. We were fortunate to have two of our board members, Dr. Duke Schell (ABAI Liaison) and Dr. Melanie Bachmeyer (Vice President), develop and present a workshop to fulfill the BACB requirement for completing the 8 Type II CEs of supervisory training. This one day workshop was held on the campus of the University of North Carolina at Charlotte. The 12 participants rated the workshop with high marks and all noted that they increased their knowledge of the subject. Many thanks go to Dr. Fred Spooner, Kimberly Bunch-Crump, and volunteer graduate students for hosting the event, directing us to our destination, and assisting us throughout the day. Thanks again to Duke and Melanie for accepting the challenge and presenting the well received *BCBA Supervisor Training: What They Didn't Teach Us in Graduate School*.

The NCABA Executive Council also offered two 3 hour workshops in Winston-Salem. These workshops were held at the Truliant Federal Credit Union's Fred J. Sarda Pavilion. Dr. Duke Schell presented a workshop intended to meet the Ethical/Legal requirements for NC psychologists and continuing education credits for practitioners certified by the BACB. This workshop, titled *Ethical interactions Between Applied Behavior Analysis and Psychology*, was also highly rated. All 28 participants indicated that they benefited from the presentation. The second workshop, *Using the Verbal Behavior Milestones Assessment and Placement Program (VB-MAPP) for Language Assessment and Programming* was presented by Mark Stafford MA, BCBA of Stafford Behavioral Consulting, PLLC. This workshop was also rated highly by the 22 attendees. We appreciate the work, time and effort that these gentlemen put into their presentations and their willingness to share their knowledge with us. A special Thank You goes to Csilla Dunn of Truliant Credit Union who helped us secure this new venue and supported us through the entire process.

NCABA Survey Results

The NCABA Executive Board designed a survey intended to 1) assess member agreement with current and potential purposes of NCABA, 2) gather member opinions about autism insurance legislation and NCABA's role in supporting it, and 3) get member input about potential governance of the practice of behavior analysis in North Carolina. The survey was sent on September 3rd, 2013 to the 235 members of NCABA and half of these members completed the survey by the December 4th deadline. Results will be emailed to all members, but a brief summary of these results can be found below.

The majority (71%) of the members who completed the survey were full members of NCABA. Most indicated that they have advanced degrees (77%) and work in the areas of intellectual & developmental disabilities or autism. Of the respondents 45% were certified by the Behavior Analyst Certification Board (BACB) and 38% were licensed by the North Carolina Psychology Board.

Per our bylaws, the purpose of NCABA is to promote the analytical science of behavior and its associated technology within North Carolina. Members supported our current methods of meeting this purpose. More than 95% agreed that our organization should continue to serve as a professional reference group for those whose work involves ABA, promote research to advance understanding of human behavior, identify and promote the use of effective, humane treatment, and organize and sponsor an annual conference. Eighty-four percent agreed that we should continue to disseminate a newsletter devoted to technical achievement in ABA and other matters associated with it and to support allied organizations in service provision for people with disabilities.

Members were asked to rate other potential purposes including promotion of autism insurance, the independent practice of BCBAs, and assigning official liaisons to APBA & NCPA. Over half of the respondents agreed with these potential purposes, though the level of agreement was somewhat lower than the strength of agreement with the current purposes. Seventy three percent of those responding to the survey supported increased dues/fees to support the potential purposes listed. Of those supporting an increase in fees, 34% supported a \$10 increase, 31% a \$20-\$40 increase and 8% supported a \$50-\$100 increase.

A number of survey questions were asked about BCBA practice in North Carolina. Sixty nine percent of the responders indicated that BCBAs should practice independently. Forty eight percent supported a licensing board for BCBAs separate from the NC Psychology Board with 26% volunteering to help create a North Carolina BCBA Practice Board.

At the time of the survey, legislation to provide autism insurance coverage, that also included the exemption of BCBAs from state licensing requirements, was being proposed in NC House Bill 498. Members were asked about their support of the various components of the bill. Eighty percent or more of the respondents supported the no limits on visits, no denial based on nature of service, no limits to other benefits, and the parity components of the Bill. The age limit and maximum benefit components were only supported by approximately 35% of the respondents. Seventy two percent of those who completed the survey supported the BCBA exemption and 75% agreed that NCABA should support this bill.

We would like to thank all of our responders for taking the time to complete this survey. The board has reviewed and discussed the results and continues to use the information for reference in current discussions. 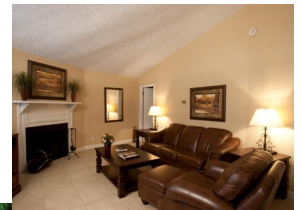
