2016 NCABA Conference will be held February 24th, 25th & 26th in Wilmington, NC

Our 27th annual NCABA Conference will be held in Wilmington at the Riverside Hilton. The Riverside Hilton is a landmark on the Wilmington Riverfront in downtown Wilmington, North Carolina that delivers a blend of historic charm, modern comfort and southern hospitality. Located on the Cape Fear Riverfront in Wilmington's famed historic district, the hotel is an easy walk to popular attractions including the Battleship North Carolina, Henrietta III sightseeing cruise, Ghost Walk of Old Wilmington, shopping, dining and nightlife. Wilmington is also home to University of North Carolina Wilmington, which houses the state's only program that offers a masters degree in applied behavior analysis. Invited speakers include Jim Johnston (Auburn University), Adam Ventura (World Evolve and COEBO), Jarrett Barnhill (University of North Carolina School of Medicine), Cynthia Anderson (Appalachian State University), Molly Pinney (CEO Global Autism Project), Kristie Thompson (OptumHealth Behavioral Solutions), Lorri Unumb (Autism Speaks), Patrick Ballantine (Autism Speaks), Michael Perone (West Virginia University), Jim Carr (Behavior Analyst Certification Board), and Patrick Friman (Boys Town). Three pre-conference workshops will be held on Wednesday morning with presentations provided by Jim Johnston, Dennis Reid (The Carolina Behavior Analysis and Support Center) and Jeannie Golden (East Carolina University). On Thursday morning, we are offering twelve concurrent sessions on a number of topics for a variety of populations across diverse settings. The conference will wrap up with two post-conference workshops on Friday afternoon. One workshop will be presented by Patrick Friman and the second will be presented by Kerin Weingarten and Erica Brown (Carolina Center for ABA and Autism Treatment). The pre- and post-conference workshops are each approved for 3 BACB Type II credits and 3 NCPA Category A credits. **Thirteen** additional BACB Type II credits and 9 NCPA Category A credits can be obtained by attending approved sessions in the regular program. Conference Workshops

Pre-Conference Workshop I - *Presenter: Jim Johnston, Ph.D., BCBA-D, “Talking About Behavior: What ABA Practitioners Need to Know About Radical Behaviorism and Why”* Skilled ABA practice requires expertise in the basic science of operant behavior, methods of measuring and evaluating behavior change, the literature and technology of ABA, and the conceptual framework – radical behaviorism - that is consistent with the science underlying ABA. This presentation will focus on the last of these requirements. It will first consider the reasons why expertise in making radical behaviorism an integral part of ABA practice is important. This argument will then **be supported with** regulatory and practical benefits, including examples of circumstances in which a practitioner’s conceptual orientation can lead in different therapeutic directions. Much of the workshop will include a review and limited discussion of the different conceptual topics that ABA practitioners should master and bring to their daily work.

Pre-Conference Workshop II - *Presenter: Dennis H. Reid, Ph.D., LP, BCBA-D, “Behavioral Supervision: A Focus on Effectiveness, Practicality, and Acceptability”* This workshop will describe evidence-based strategies for training relevant work skills among direct support staff in human service and education agencies, supporting day-to-day work quality, and correcting nonproficient work performance. In presenting the strategies, a particular focus will be on promoting quality work while also enhancing staff work enjoyment from a motivational perspective. A focus will also be on how to make effective training and supervision practices more practical and time-efficient based on recent research in organizational behavior management in human service agencies.

Pre-Conference Workshop III - *Presenter: Jeannie Golden, Ph.D., BCBA-D, “Treating Children with Psychiatric Disorders: Understanding the Impact of Functions & Motivational Operations”* Typically, functional behavioral assessment (FBA) has been used with children with developmental disabilities, including autism spectrum disorders. The goal of FBA is to identify the function of aberrant behaviors and to teach acceptable replacement behaviors that can serve the same functions. Traditional counselors view aberrant behaviors in children with psychiatric disorders as symptoms of underlying constructs and use the diagnosis as a reason for these behaviors, proposing more global treatments such as evidence-based therapies or medications. On the other hand, behaviorists view those behaviors as serving an environmental function. Once the environmental function of a psychiatric symptom is identified, it can be treated effectively by replacing it with more acceptable behaviors serving the same functions. However, there are several components that are often missing in the analysis of behavior that is related to psychiatric diagnosis. These include the analysis/understanding of motivating operations in the form of private events such as physical sensations, bio-behavioral states, and covert tacts/mands as well as learning history with particular discriminative stimuli for reinforcement or punishment. **Presenters in this symposium** will discuss the process of conducting FBAs and function-based treatments, taking into account the aforementioned components with several different symptoms of psychiatric diagnoses. **Symptoms include: disturbed attachment, callousness and lack of emotionality, non-suicidal self-injury and oppositional and defiant behaviors.**

Post-Conference Workshop IV - *Presenter: Patrick C. Friman, Ph.D., BCBA-D, “Anxiety in Persons on the Spectrum: The Psychological Equivalent of Fever”* Anxiety is a term used for the most common group of psychological/behavioral problems affecting mankind. These problems are so prevalent in typically developing persons that they could plausibly be thought of as the psychological equivalent of fever. Pertinent to this presentation, these problems are even more prevalent in persons with Autism Spectrum Disorders (ASD) than in typically developing persons. One obstacle to clinical progress is the term anxiety itself. It is a hypothetical term that has never been adequately defined. For example, the most authoritative book on anxiety disorders does not even attempt a definition for the first 100 pages and the one then offered is a long paragraph that itself includes a number of undefined terms. Nonetheless, a number of effective treatments have been developed. Although better understanding of the term and the phenomena to which it refers would advance treatment even more, the purpose of this talk is merely to describe what is currently known. For example virtually all of the problem behaviors associated with anxiety involve either avoidance or escape. And virtually all of the effective treatments involve approach or exposure. This talk will discuss anxiety in straightforward terms, illuminate the extent to which it affects virtually everyone to a certain degree and more to the point of the conference, the extent to which it affects persons with ASD even more. It will also discuss treatment both in terms of experimental study and clinical application. Finally, because the research on treatment of anxiety in persons with ASD is so limited, the talk will extrapolate from the abundant literature on treatment of anxiety in typically developing persons.

Post-Conference Workshop V - Presenters: Kerin Weingarten, Ph.D., BCBA & Erica Brown, M.A., BCBA, "Let's Get Ethical: Applying the BACB's Professional and Ethical Compliance Code" Effective January 2016, the BACB will replace their Guidelines for Responsible Conduct for Behavior Analysts and Professional Disciplinary and Ethical Standards with a new, single code for ethical conduct- the Professional and Ethical Compliance Code for Behavior Analysts. This CEU event will review the Compliance Code and the revisions that have been made to the BACB's disciplinary system. Because difficult and blurred situations arise, BCBA's and their technicians need to be fluent on the most appropriate ways to respond and serve our clients in situ. This CEU event will focus on increasing awareness of, labeling, analyzing, and identifying solutions to common ethical scenarios that professionals encounter.

Update on Behavior Analyst Licensure in North Carolina

The behavior analyst licensure bill (HB714) passed the House during the long session in the summer of 2015, but was not heard in the Senate. It is expected that the bill will be heard in the Joint Governmental Operations Committee sometime in January or February, 2016 (before the legislative session begins). If the bill passes that committee, it should be heard in the Senate in the short session, which begins on April 25, 2016.

The Behavior Analyst Certification Board (BACB) and Association of Professional Behavior Analysts (APBA) sponsored a workshop on regulation of the practice of applied behavior analysis in August, 2015. NCABA was invited to attend the workshop because of the current legislative activity in North Carolina. NCABA President Elect, Melanie Bachmeyer, attended the workshop on behalf of NCABA to gain and share information regarding the regulation of the practice of applied behavior analysis to practicing behavior analysts in North Carolina. The workshop agenda included information regarding a model act for licensing/regulating behavior analysts, the legislative and regulation processes, and issues with current laws and regulations affecting the practice of behavior analysis in other states.
