**Notice of Fee Increases**

The NCABA Executive Council has voted to increase conference fees by \$5.00 for the 2013 conference. It has been five years since the last fee increase, at which time the conference fees were increased by \$10.00. The fees to attend the 2013 conference will be as follows:

Full Member	\$65.00
Paraprofessional Member	\$35.00
Student Member	\$15.00
Non-member	\$95.00

This increase will allow the organization to continue to offer quality educational opportunities and social events at our annual conference and will cover the fees associated with accepting credit and debit cards that 82% of the membership requested on the 2012 conference evaluation form. ## From HB487 to HB1157

In March the House Select Committee on Military Affairs discussed the original idea contained in House Bill 487 (HB487) which involved exemption of behavior analysts from the North Carolina Psychology Practice Act. The North Carolina Psychological Association (NCPA) informed the committee of their opposition to the original bill at this discussion, and they suggested that the topic of practice by Board Certified Behavior Analysts (BCBAs) would be better addressed during a long session of the legislature. At the end of April, the original idea in HB487 came up for discussion again by the Select Committee on Military Affairs. NCPA spoke to the committee at that time and noted major concerns about exemption. The outcome of that meeting was that the committee recognized the issues surrounding the practice of behavior analysis by BCBAs and that those issues needed to be addressed, but the committee would not recommend an exemption from North Carolina law based on the need for public protection in North Carolina statutes.

Representatives Parfitt and Shepard, who are members of the House Select Committee on Military Affairs wanted to move forward to address and solve the issues. They requested a meeting with representation from NCPA, NCABA, and the Psychology Board along with legislative staff. After discussion at that meeting, Representatives Parfitt and Shepard requested that HB1157 be drafted. The draft was to be based on the discussion at that meeting and the proposed committee substitute for HB487 that had been prepared last year by the NCPA-ABA work group. Note that the proposed committee substitute for HB487 was the substitute bill discussed by the panel at the NCABA Conference in February.

HB1157 was drafted, but it did not come up in the short session of the legislature, so that bill is now dead. There continues to be strong interest in introducing legislation on the topic of BCBA licensure. The fact that the HB1157 did not go anywhere means that there is opportunity for more discussion and review by stakeholders prior to the introduction of another bill.

## 2012 Conference Review

The NCABA Executive Committee would like to extend a big thank you for supporting and attending the NCABA 23rd Annual Conference that was held at the Twin City Quarter in Winston-Salem, February 15-17, 2012. The conference included three pre-conference workshops, three post-conference workshops, seven invited addresses, one panel discussion, a student symposium and nine concurrent sessions devoted to the topic of behavior analysis, as well as our annual poster session, social, and silent auction events.

The topics presented at the pre- and post-conference workshops varied, including Preparing a Child for Transitions to Less Restrictive Educational Settings (Mark Sundberg, Ph.D., BCBA-D, Sundberg & Associates), Ethical Issues Posed by Behavior Analysis in Psychology (Duke Schell, Ph.D., BCBA-D, Director of Psychology, J. Iverson Riddle Developmental Center), A Weight Loss Program for Individuals with Disabilities (Richard Saunders, Ph.D., Senior Scientist, & Muriel Saunders, Ph.D., Assistant Research Professor, University of Kansas), Teaching Intraverbal Behavior to Children with Autism: Analysis, Assessment, and Intervention (Mark Sundberg, Ph.D., BCBA-D, Sundberg & Associates), Functional Applications for Sound Generating Devices (Voice Output Communication Aides) (Muriel Saunders, Ph.D., Assistant Research Professor, & Richard Saunders, Ph.D., Senior Scientist, University of Kansas) and Disability to Management: From Function to Treatment (Martin Ivancic, Ph.D., BCBA-D, Psychologist, J. Iverson Riddle Developmental Center). A total of 118 people participated in the pre-conference workshops and 98 participated in the post-conference workshops. Each workshop provided 3 CEUs for psychologists and Board Certified Behavior Analysts.

A total of 210 people attended the 2012 NCABA conference, which is a new attendance record! We were extremely fortunate to have a number of individuals preeminent in the field in attendance and several provided invited addresses that were well attended. Special appreciation is given to our invited speakers, including: Carol Pilgrim from the University of North Carolina at Wilmington, Tim Ludwig from Appalachian State University, Richard Saunders from the University of Kansas, Dennis Reid, Director of Carolina Behavior Analysis and Support Center, Mark Sundberg from Sundberg and Associates, Jim Bodfish from the University of North Carolina at Chapel Hill, and Ray Pitts from the University of North Carolina at Wilmington. We were also fortunate to have a wonderful array of topics presented during nine concurrent sessions. Bethany Smith and colleagues from the University of North Carolina at Charlotte presented two of the sessions. Ruth

Hurst from Central Regional Hospital and Chad Drake from the University of South Carolina at Aiken rounded out the opening sessions. The next group of concurrent sessions included Charles Wood and colleagues from the University of North Carolina at Charlotte, Rod Realon, and Christine Hughes from the University of North Carolina at Wilmington. Muriel Saunders from the University of Kansas and R. Trent Codd III from the Cognitive-Behavioral Therapy Center of WNC, PA rounded out the concurrent sessions. Ya-yu Lo from the University of North Carolina at Charlotte chaired our panel, "Licensing Behavior Analysts in North Carolina: House Bill 487 and Beyond" with panelists from the administration of the North Carolina Psychological Association and the Executive Committee of NCABA.

At the opening of the conference, Mark Stafford acknowledged the contributions of the late Gerald (Jerry) Shook and dedicated the conference to Jerry's memory. Some very deserving individuals received awards and a big round of applause during the opening session. Diane Browder received the Fred Keller Excellence in Behavior Analysis Award. Darcie Rhodes received the Technical Utilization Award. Bethany Smith received the Student Scholarship Awards, and Thomas Thompson received the "Do Things" Award. Congratulations to all award recipients!

The NCABA Student Representative, Susan Flynn from the University of North Carolina at Charlotte, did a wonderful job of organizing and chairing our Student Symposium. Student presenters included Megan Brandon, B.A., East Carolina University, Adrienne Anderson, M.Ed., University of North Carolina at Charlotte, Kelly L. Hayes, B.A., East Carolina University, Ozalle M. Toms, M.Ed., University of North Carolina at Charlotte, and Ashley Bouknight Wingard, M.S., East Carolina University. Following the symposium, a student gathering was held to provide time for students to network with other students and meet and talk with Student Representative candidates prior to voting.

The Poster session included posters from graduate student researchers as well as practicing professionals. This year, we awarded prizes to outstanding posters in two categories: graduate student and professional.
