CEU Helper Coming to 2020 Annual Conference!

Anyone wishing to obtain CEs for attending the conference will need to bring a personal device, such as a phone or tablet, with the free CEU Helper app installed (available in your app store). A free CEU Helper account must also be established within the app, so be sure to create an account if you do not already have one. Your prepared device will allow you to scan in and out of sessions, maintain a record of your CEs, and even issue certain CEs instantly following the conference!

Spotlight: Applied Behavior Analysis and PTSD

ABAI’s Autism Special Interest Group (SIG) has the largest membership of any SIG and provides up-to-date information about autism research and clinical practice. Some of the objectives of the SIG include promoting evidence-based practices, protecting individuals with ASD and their families from ineffective treatments, and serving as a scientific reference for its group members.

Most recently, the Autism SIG has taken action to address a research publication linking exposure to ABA therapy with increased PTSD symptoms. In the study, Kupferstein surveyed 460 autistic adults who reported receiving ABA therapy as children. The study found that nearly half of the ABA-exposed participants reported posttraumatic stress symptoms. The results of this study have been widely discussed on social media platforms and have contributed to ongoing controversy surrounding autism treatment. This publication has now been used as evidence of the harmful consequences of treatments based on the principles of ABA, despite the study having serious methodological and conceptual flaws.

To address this, members of the Autism SIG’s executive board recently published a response. Leaf and colleagues sought to “evaluate the methodological rigor with respect to the use of hypothesis testing, use of indirect measures, selection of respondents, ambiguity of definitions, measurement system, and framing of the experimental question when conducting the correlation analysis.” Their analysis found several issues with the study and recommends that Kupferstein’s results be viewed with extreme caution. This paper may serve as a reference point, should any providers or individual clinicians be provided with Kupferstein’s article as evidence of ABA causing PTSD.

Student Corner

- ◆ Student members can get involved in a number of ways:
 - *Student Representative*: run for the position of student representative and serve on the NCABA Executive Council. It is a one year term and a great way to make an impact.
 - *Student Symposium*: submit a proposal to present your research in the student symposium. If accepted you would provide a 15-20 minute presentation of your work along with other students. It is a great opportunity to network with other students, receive feedback from experts in the field, and interact with leaders in ABA in North Carolina.
 - *Poster Session*: submit a proposal and present your research during the poster session. Two \$50 awards will be given out, one for the best graduate poster and one for the best undergraduate poster.
- ◆ Interested in attending the conference but have concerns about the costs? Consider one of the following options:
 - *Student Scholarship Award*: The winner will receive \$100. In addition, the conference fee the following year is waived. Candidates need to have advanced coursework and practical experience in behavior analysis and need to be nominated by a faculty member or internship supervisor by January 7th.
 - *Work the Registration Booth*: NCABA will be waiving the registration fees for the first 30 student members who volunteer to work one hour at the registration booth during the conference. If you are a student member then plan to register as soon as registration opens in December and select the volunteer option.

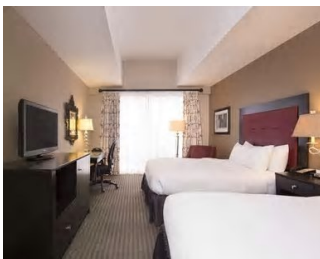

~Fred Keller Excellence in Behavior Analysis Award~

Given to a person who has made an outstanding contribution to the field of behavior analysis in North Carolina and whose work demonstrates the highest quality in the application of behavior analytic principles.

~Technical Utilization Award~

Given to a person who has not been formally trained in behavior analysis, but who has excelled at applying behavioral technology in their work. To qualify, the candidate must not have received formal, graduate level training in behavior analysis. The recipient of this award will receive complimentary conference registration to the next annual conference and a \$100.00 stipend toward conference expenses.

~Student Scholarship Award~

Given to a student who has excelled in their advanced course work and who has demonstrated excellent behavior analytic skills in their advanced course work and practical experience in behavior analysis, and who would benefit from attending the conference.
