2020 Annual Conference Review

On behalf of the NCABA Executive Committee, I would like to thank our attendees, speakers, and membership for supporting our 31st Annual Conference in Raleigh February 19-21, 2020. We were honored to host incredible speakers who shared their expertise in two pre-conference workshops, two post-conference workshops, nine invited addresses, a student symposium, nine concurrent sessions, and a poster session.

Our attendees had the opportunity to learn from nine invited speakers who traveled across the state and country to present on a variety of topics such as: behavior analytic equations (Cary Trump, PhD, BCBA-D, University of Northern Colorado); transferring skill-based treatment to caregivers (Kelsey Ruppel, PhD, BCBA, LABA, FTF Behavioral Consulting); behaving analytically in the provision of school supports (Robert Pennington, PhD, BCBA-D, UNC Charlotte); ethical issues in the treatment of feeding difficulties in children (Melanie Bachmeyer, PhD, LP, BCBA-D, UNC Wilmington); teaching perspective-taking skills to individuals with autism (Adel Najdowski, PhD, BCBA-D, Pepperdine University); moving from 1:1 intervention to small group instruction (Patrick McGreevy, PhD, BCBA-D, Patrick McGreevy & Associates); update from the BACB Ethics Department (Tyra Sellers, JD, PhD, BCBA-D and Sara Lichtenberger, PhD, BCBA-D, BACB); behavior analysis in the mainstream of daily life (Patrick Friman, PhD, ABPP, Boys Town); and behavioral pharmacology of impulsive and risky choice (Raymond Pitts, PhD, UNC Wilmington).

Our 147 pre-conference workshop attendees enjoyed presentations on teaching functional life skills (Patrick McGreevy, PhD, BCBA-D, Patrick McGreevy & Associates) and Balance which is a home-based collaborative approach to addressing emerging behavior problems (Kelsey Ruppel, PhD, BCBA, LABA, FTF Behavioral Consulting). We also had a total of 103 attendees at our post-conference workshops on public speaking by behavior analysts (Patrick Friman, PhD, ABPP, Boys Town) and strategies for providing high quality supervision (Tyra Sellers, JD, PhD, BCBA-D and Sara Lichtenberger, PhD, BCBA-D, BACB).

The nine concurrent sessions covered an extensive variety of topics, and were presented by local and national professionals: Monique Baker, Kat Tinker, & Breana Dutcher (Effective Interventions); Shanun Kunnavatana, Casey Clay, & Kristen Kelley (Easterseals UCP of NC & VA); John Keller (The Geriatric Behavior Laboratory - GerBL); Tracy Vail, Amy Swaim, & Jean Jarrett (Let's Talk Speech and Language Services); Kellie Syfan & Aakriti Tripathi (Carolina Center for ABA); Holly Moses (Crossvine Clinical Group); Jeannie Golden, Corbett Hall, Drenee Bryant, & Kristin Spruill (East Carolina University); and Patrick O'Leary & Rebecca Cardillo (Positive Behavior Supports Corp.).

A record high of 475 people registered for the 2020 conference. We thank each and every one of you for your attendance at the invited and concurrent addresses. Because

This year, more than 3000 BACB continuing education credits were awarded.
