33rd Annual NCABA Conference Announcement

Thank you to the members who responded to our survey regarding our 2022 Annual Conference. We received almost 250 responses with helpful feedback to guide our conference planning. Based on the feedback at this time, we are planning to move forward with our in-person Annual Conference in February and will evaluate the possibility of adding a hybrid option to view remotely as we get closer to the conference. In order to safely hold our conference in-person, we will be requiring proof of vaccination or negative COVID test within 3 days of the conference, mandatory mask usage at all times when not eating or drinking, spaced seating options, increased cleaning of high-surface areas throughout the event, and sanitization stations located throughout the venue. These safety measures will be implemented as a minimum and we will continue to evaluate if other precautionary measures are needed as we move closer to the event.

We are currently planning the 33rd Annual NCABA Conference February 23-25, 2022 in Winston-Salem, NC at the Benton Convention Center. The location is steps away from both the Marriott and the Embassy Suites as well as many dining options in downtown Winston-Salem. We're honored to be hosting an exciting lineup of speakers, including invited speakers: Camille Kolu (Cusp Emergence), Cynthia Anderson (May Institute), Nicole Gravina (University of FL), Tom Cariveau (UNC-W), Caio Miguel (California State University, Sacramento), Carol Pilgrim (UNC-W), Shahla Alai (University of North Texas), and Danielle LaFrance (California State University, Sacramento). Pre-conference workshops will be held on Wednesday morning with presentations provided by Nicole Gravina and Camille Kolu. Post-conference workshops will be held on Friday afternoon with a presentation by Caio Miguel and a presentation by Shahla Alai and Malika Pritchett. BACB and NCPA CEs are being sought for the various invited, concurrent, and workshop presentations. Conference registration will be opening in December and we ask for our members to register early to help us with conference planning. May 2021 S103 was signed into law by Governor Cooper.

August/September 2021 Governor, Senate, and House licensure board appointees were made.

FAQs:

Q: When will the NC Behavior Analyst Licensure Board be formed?

A: Governor, Senate, and House licensure board appointees were made in August/September 2021.

- Q: When will I be able to apply for my license?
- A: The NC Behavior Analyst Licensure Board is currently working on developing the rules, regulations, and processes for licensure. We will update you as soon as we have more information.
- Q: Now that the licensure law has passed, can BCBAs practice independently?
- A: The NC Psychology Board states that "Behavior analysis is included in the definition of the practice of psychology, pursuant to NC Gen. Stat. Sec. 90-270.2(8). In order to practice psychology in North Carolina, including behavior analysis, one must be licensed by the NC Psychology Board, unless one is exempt from licensure pursuant to NC Gen. Stat. Sec. 90-270.4."

Thus, until/unless individuals have a NC license to practice behavior analysis, they may be subject to investigation by the NC Psychology Board if they are not working under the supervision of a LP/LPA.

- ♦ Student members can get involved in a number of ways:
 - <u>Student Representative</u>: run for the position of student representative and serve on the NCABA Executive Council. It is a one year term and a great way to make an impact.
 - <u>Student Symposium</u>: submit a proposal to present your research in the student symposium. If accepted you would provide a 15-20 minute presentation of your work along with other students. It is a great opportunity to network with other students, receive feedback from experts in the field, and interact with leaders in ABA in North Carolina.
 - <u>Poster Session</u>: submit a proposal and present your research during the poster session. Two \$50 awards will be given out, one for the best graduate poster and one for the best undergraduate poster.
- Interested in attending the conference but have concerns about the costs? Consider one of the following options:
 - <u>Student Scholarship Award</u>: The winner will receive \$100. In addition, the conference fee the following year is waived. Candidates need to have advanced coursework and practical experience in behavior analysis and need to be nominated by a faculty member or internship supervisor by January 7th.
 - <u>Volunteer at the Conference</u>: NCABA will be waiving the registration fees for the first 20 student members who volunteer to work one hour during the conference. If you are a student member then plan to register as soon as registration opens in December and select the volunteer option.

~Fred Keller Excellence in Behavior Analysis Award~

Given to a person who has made an outstanding contribution to the field of behavior analysis in North Carolina and whose work demonstrates the highest quality in the application of behavior analytic principles.

~Technical Utilization Award~

Given to a person who has not been formerly trained in behavior analysis, but who has excelled at applying behavioral technology in their work. To qualify, the candidate must not have received formal, graduate level training in behavior analysis. The recipient of this award will receive complimentary conference registration to the next annual conference and a \$100.00 stippend toward conference expenses.

~Student Scholarship Award~

Given to a student who has excelled in their advanced course work and who has demonstrated excellent behavior analytic skills in their advanced course work and practical experience in behavior analysis, and who would benefit from attending the conference. The sponsor who nominates the student should be a faculty member or internship supervisor who can briefly indicate how the student's work demonstrates potential for behavior analysis application in North Carolina.
